- Check in is at 4:00 pm; check out is at 10:00 am. This is slightly flexible but must be prearranged with management and will depend on housekeeping's schedule.
- No smoking inside cottage.
- No pets inside cottage or on premises.
- No more people sleeping over than there are beds to hold them (max 7 people).
- No burning in the fireplace insert unless instructions have been reviewed with Dan McLaughlin or Barbara Somers.
- No burning campfires.
- Parking for 2 vehicles only. Additional vehicles may come with prearranged scheduling and small daily fee.
- Please turn propane tank off in between uses.
- Please keep radio and TV's to a reasonable volume.
- No loud talking or noise after 11:00 pm. Voices and noises carry a great distance in the evening hours and early in the morning, as well.
- Please make use of the many footbaths and doormats provided to keep sand to a minimum on our new laminate flooring!! THANK YOU!
- **Renters must be conscious of the amount of gray water going into the septic system. Showers must be quick and kept to a minimum, toilet flushing limited to necessity and don't leave water running in the kitchen sink. Keeping wastewater to a minimum is helpful to everyone and we greatly appreciate it!!**
- **Please cross the street to the beach at the end of the driveway. This allows the best visibility for traffic coming around the bend.**
